Directions to State Information Center: From North: Take Hwy 54 or 63 to Jefferson City. Take the first exit (Main Street) after crossing the bridge. Turn left on Main. Go 4 blocks. Turn left into State Information Center's parking lot. From South: Take Hwy 54 to Jefferson City. Follow signs for Hwy 50 East. Turn left on Missouri Boulevard. Go 2 blocks. Turn left on Main Street. Go one block. Turn right into parking lot.

From West: Take Hwy 50 to Jefferson City. At first stoplight, turn left. Go 2 blocks, turn left on Main Street. Go 1 block, turn right into parking lot. From East: Take Hwy 50 to Jefferson City. Turn right at Missouri Boulevard. Go 2 blocks. Turn left on Main Street. Go one block. Turn right into parking lot.
